1. INTRODUCTION: Please read the Official Rules (“Rules”) of the EMC WORLD 2016 GLOBAL SERVICES SWEEPSTAKES (the “Sweepstakes”). To participate, you must agree to unconditionally accept and comply with the Rules, and the decisions of and interpretations of these Rules by the sponsor and administrator, EMC Corporation, 176 South St., Hopkinton, Massachusetts 01748, U.S.A. (“Sponsor”). Winning a prize is contingent upon fulfilling all requirements set forth herein. By entering you agree to comply with these Rules. If you do not agree, do not enter the Sweepstakes or accept a prize. In these Rules, “you” and “your” refers to the individuals that enter the Sweepstakes. Unless otherwise stated, all times herein are in Pacific Time.

Sweepstakes Definition. A ‘sweepstakes’ as stated in the Rules is the equivalent of a ‘prize draw.’ If applicable within a jurisdiction, references to ‘sweepstakes’ in connection with this Sweepstakes shall be understood to mean ‘Prize Draw.’

2. 4. POTENTIAL WINNER SELECTION AND NOTIFICATION: On or about each day’s drawing times listed on the Chart above, one (1) entrant will be randomly selected by Sponsor representatives from among all Entries received during the Entry Period indicated in the Chart for that day. You do not need to be present at the time a potential winner is selected in order to win a prize. Each potential winner will be notified by email using the information associated with the Entry on the day the potential winner is chosen and will have won a prize subject to fulfillment of all requirements under the Rules. Winners will be asked to complete, sign and return the Sponsor’s Prize Claim Documents defined below. **The odds of winning depend upon the number of Entries received prior to each drawing.**

Disqualification. Release of Sweepstakes Entities. 8. GENERAL TERMS: Entries not complying with these Rules are subject to disqualification. Sponsor reserves the right to remove any entrant from the Sweepstakes for violation of these terms and conditions, or if entry in the Sweepstakes violates the laws applicable in the jurisdiction where the entrant is employed or lives. Sponsor may disqualify Entries that are mechanically reproduced, forged, robotic, programmed, script, macro, software-generated or other automated or third party or multiple entries in excess of the number permitted hereunder Sponsor reserves the right in its sole discretion to disqualify any individual who is found in Sponsor's sole judgment to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEBSITE, TAMPER WITH THE ENTRY OR WINNER SELECTION PROCESS, OR OTHERWISE UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO COOPERATE IN THE PROSECUTION OF ANY SUCH INDIVIDUAL(S) AND TO PURSUE ALL REMEDIES TO THE FULLEST EXTENT PERMITTED BY LAW.

Modification, Suspension or Termination. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. If Sponsor is prevented from awarding a Prize or continuing with the Sweepstakes as contemplated herein by any event beyond its control, Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes. For any cancellation, termination or suspension, or any changes made to these Rules, notice thereof will be sent by email to all visitors recorded as having visited the EMC Global Services booth, entered the Sweepstakes, and/or by posting the changes in Sponsor's booth. If the Sponsor decides to reconvene the Sweepstakes after a suspension, the determination of the Prize winner will be made, from among all eligible, non-suspect entries and registrations received, as Sponsor determines in its sole discretion. Inclusion in such drawing shall be each Entrant's sole and exclusive remedy under such circumstances. Any discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on the registration website, App, or Event website and/or the terms and conditions of the Rules, the Rules shall prevail, govern and control.

9. TAXES: The value of the Prize may be taxable to the winner as income. Damages; Disputes. Entrant agrees that: [a] any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the Commonwealth of Massachusetts, U.S.A.
